The District was notified on November 23, 2020 that PG&E did not approve the underground utility for the expansion of AT&T's site. PG&E is requiring AT&T to have the power installed overhead. The lines will come in from the pole on Lincoln Blvd, AT&T will install a new pole within the 20x15 leased area.

AT&T has prepared an agreement for review and possibly approval. A draft Agreement was reviewed and approved at the last Board Meeting on Monday, January 25, 2021. Attached is a revised Agreement, listing the Grantee as New Cingular Wireless PCC, LLC, a Delaware limited liability company.

The District's counsel Robert Hunt worked with AT&T's attorneys in the revision process.
